

**City of Auburn Budget Resolution  
Fiscal Year 2009-10**

WHEREAS, Michigan Public Act of 1968, as amended, requires an appropriation act adopting budgets for the General Fund and all Special Revenue Funds; and

WHEREAS, Public Act 621 of 1978, the Uniform Budget Act, requires that responsibility for the budget be designated and that itemization of accumulated surpluses or deficits from prior years, current year and estimated surplus or deficits for the budget must be provided; therefore

BE IT RESOLVED, that the City of Auburn Commission adopts the General Fund Budget and Special Revenue Funds in the amount of \$ 1,237,440

WHEREAS, the City Commission, after such hearing thereon and consideration thereof, did adopt said budget as represented herein and fixed the tax of 10.0000 mills for general operating purposes, and 3.0000 mills for Road repairs, to be raised by a general ad valorem tax upon owners of Real and Personal Property in the City of Auburn by the authority granted, and in accordance with the Michigan Constitution, the General Property Tax Act 206, Michigan Public Acts of 1893, as amended, and City Charter, Article VII.

THEREFORE BE IT RESOLVED, that the City Administrator be designated as responsible for the budgets, and given the authority to make budgetary transfers among appropriations and

BE IT FURTHER RESOLVED, that the following itemization of accumulated surplus be accepted.
